From the Managing Director, Tamil Nadu Skill Development Corporation, letter RC.No.45/SDC-1/2018, dated 15.03.2018 and 18.04.2018.

ORDER:

In the letter dated 15.03.2018 read above, the Managing Director, Tamil Nadu Skill Development Corporation has stated that the Tamil Nadu Skill Development Corporation is the Nodal Agency for all skill training programmes providing job oriented skill training in 23 sectors across the State. As per Skill Gap Study of National Skill Development Corporation, State Human Resource requirement for 2012-2017 is 62.80 Lakh and for 2017-2022 will be 95.14 Lakh. In order to scale up the skilling activities to meet the skill gap demand and to train minimum of one lakh youth as per budget announcement 2016-2017, Expression of Interest was invited from private training providers by Tamil Nadu Skill Development Corporation. After scrutiny of the inspection reports received from the Regional Joint Directors of Employment and Training Wings based on their physical inspection, Tamil Nadu Skill Development Corporation has empanelled 62 training providers.

2. The Managing Director, Tamil Nadu Skill Development Corporation has stated that, in 14th Board meeting held on 30.01.2018, 62 proposals from the new empanelled training providers and 66 proposals for additional batches for already empanelled training providers, two proposals for release of additional funds and one proposal for administrative sanction of capital and operating expenditure have been placed for skill training at an estimated cost of Rs.5098.96 lakh. The proposal submitted by the training providers have been verified with Government of India, Ministry of Skill Development and Entrepreneurship Notification dated 15.07.2015 and accordingly the proposals have been prepared.

3. The Managing Director, Tamil Nadu Skill Development Corporation has further stated that, the following 133 proposals from training providers, two proposals for release of additional fund sanction and one proposal for administrative sanction for capital and operating expenditure in Tamil Nadu Skill Development Corporation office were approved by the Board of Directors of Tamil Nadu Skill Development Corporation in the meeting held on 30.01.2018:-

The Managing Director, Tamil Nadu Skill Development Corporation/Commissioner of Employment and Training has requested the Government to sanction a sum of Rs.5098.96 lakh to impart short term skill training to 48575 youth through the training partners and for release of two additional funds and for capital & operating expenditure of the

Office of the Tamil Nadu Skill Development Corporation as approved by the 14th Board Meeting of Tamil Nadu Skill Development Corporation.

- 5. The Government have carefully examined the proposal of the Managing Director, Tamil Nadu Skill Development Corporation at paragraph 4 above and accordingly sanction a sum of Rs.5098.96 lakh (Rupees Fifty crore ninty eight lakh and ninety six thousand only) to impart short term skill training to 48575 youth through the training providers as detailed in the Annexures I, II and V by following the common terms and conditions as detailed in Annexure VII and release two additional funds and capital & operating expenditure of the Office of Tamil Nadu Skill Development Corporation as detailed in Annexures III, IV and VI of this order.

Textile and Apparel Sectors being spread far and wide in the country not only provide wage and self-employment to millions of people but have the capacity to transform rural economy if properly linked.

As per G.O (Ms) No. 53 Labour and Employment (S2) Department, Dated: 24.02.2016 Government have issued orders to train 4450 candidates through ATDC at a cost of Rs.155.75 /- lakh for imparting skill training programme in Textile Management sector.

Owing to the presence of widespread training centres, participated by both public and private entities, determining the quality of training rendered at different training centres is crucial to the success of the skill development programme and thus skill assessment is essential part of skill development. It is further mandated that the competency assessment of the candidate is being done by independent Assessing Bodies (AB) which are not involved in training delivery, to ensure an impartial assessment. AMHSSC has been authorized by NSDC for evolving assessing proficiencies of skills of trainees for the Apparel Sector, Made-ups and Home Furnishing for their respective subject areas.

ATDC was advised to assess 1588 candidates through Apparel Made-ups and Home furnishing Sector Skill Council (AMHSSC). The assessment cost was not included in the previous G.O (Ms) No. 53, Labour and Employment (S2) Department, Dated: 24.02.2016.

Hence, an additional fund of Rs.15,88,000/- is sanctioned for payment of assessment charges to Apparel Made-ups and Home furnishing Sector Skill Council (AMHSSC).

SCVT was formulated with the aim of streamlining the system of State run Vocational training in the State and also to submit necessary proposals regarding State run vocational training to the Government of Tamil Nadu. AMHSSC has been authorized by NSDC for evolving assessing proficiencies of skills of trainees for the Apparel Sector, Made-ups and Home furnishing for their respective subject areas.

As per G.O (Ms) No. 204, Labour & Employment (S2) Department, Dated:11.12.2015 Government have issued orders to train 4200 candidates through Tamil Nadu Slum Clearance Board.

The Tamil Nadu Slum Clearance Board was advised to assess 2700 candidates through State Council for Vocational Training and Apparel Made-ups and Home furnishing Sector Skill Council (AMHSSC). The assessment cost was not included in the above said Government order.

Hence, an additional fund of Rs.27.00 lakh is sanctioned for payment of assessment charges to State Council for Vocational Training (Rs. 18.00 lakh) and Apparel Made-ups and Home furnishing Sector Skill Council (AMHSSC) (Rs. 9.00 lakh).

Proposals for Recognition of Prior Learning (RPL) accreditation in different sectors:

Recognition of Prior Learning (RPL) is a very important function associated with National Skills Qualification Framework (NSQF). RPL can be defined as the process of recognizing previous learning, often experiential, towards gaining a qualification.

RPL is of particular significance in India, especially in the informal sector that employs more than 90% of the workforce. While there is an urgent need for skill-based training for jobs across the country, the absence of sufficient training avenues prevents the existing workforce to acquire skill training through formal channels. As a result, most of the skill acquisition takes place through informal channels such as family occupation, on-the-job experience under a master craftsman, etc. Reconciling these issues is at the core of RPL framework in India.

Integrating RPL framework within the general and vocational education systems is the need of the hour. RPL will be particularly beneficial for the youth of the country because it can enable individuals to build on skills acquired. RPL can bridge the entry restrictions of the formal training system by providing clear linkages between vocational learning and formal learning. This will not only enable the socio-economic mobility of workers, but will also facilitate professional/educational progression. An **outcome-based** approach is integral to the RPL that will recognize skills of workers irrespective of the methods/inputs utilized.

TNSDC is aiming for Recognition of Prior Learning (RPL) of skilled workers engaged in Construction, Leather, Textiles, Automobile and Health Sectors which will take the uncertified workers to next level of certified skilled work force. TNSDC has received proposals from the following agencies to assess and certify under RPL Programme.

In the G.O. (Ms.) No.70, Labour and Employment Department, dated: 14.5.2012, G.O. No.153, Labour and Employment Department, dated:14.07.2016 and G.O. No.67, Labour and Employment Department, dated:12.04.2017 Government have sanctioned a sum of Rs.225.67 lakh under salary component out of which expenditure incurred upto 31.12.2017 is Rs.190.52 lakh and the balance available is Rs.35.14 lakh.

The fund requirement under salary component for January 2018 and February 2018 for the Financial year 2017-2018 is Rs.19.00 lakh and for the Financial year 2018-19 is estimated at Rs.130.18 lakh. While sanctioning the amount the following terms and conditions may be stipulated for effective implementation of the training programme.

- 1. Training Provider shall furnish an agreement with TNSDC incorporating all the terms & conditions.
- 2. Training Provider should login to the TNSDC Web portal https://www.tnskill.tn.gov.in and upload the training details for batch creation before the commencement of training.
- 3. Training should be started after the installation of bio-metric device to record the attendance of trainees and instructors.
- 4. Aadhar Number for trainee is mandatory for enrollment in TNSDC portal.
- 5. Training Provider is responsible for mobilization of candidates, verification proposes and selection of candidates for the proposed sector training.
- 6. Training Provider should ensure assessment of training on completion of the same to those trainees who have a minimum of 85% attendance under the stipulated time frame.
- 7. Training Provider should furnish the list of trainees per batch and the same should be hosted in the Tamil Nadu Skill Development Corporation portal and Training Provider website.
- 8. Training Provider should ensure field visit to the related training area for each batch at least one to have a firsthand knowledge of Technology under usage in working environment.
- 9. Training Providers should ensure a minimum of 70% placement of candidates trained by them. The complete placement details like occupation, salary, name and address of the employer should be furnished for tracking purposes.
- 10. A Training Coordinator should be nominated by the Training Provider for coordinating the entire training programme.
- 11. Each trainee should be given a training manual for reference preferably in Tamil.
- 12. The Training provider has to send the training details by registered post to Deputy Director (Admission and Trade Test), O/o the Director of Employment and Training, Guindy, Chennai-32, and email id: detasmt@gmail.com 15 days in advance, enabling to conduct the Assessment by SCVT with a copy marked to TNSDC dettndsm@gmail.com.

- 13. Successful candidates will be given a State Council for Vocational Training (SCVT) / Sector Skill Council Certificate.
- 14. Training Provider will be provided 25% of the training cost of every batch once the admission completed and details received from Training Provider. Another 25% of the training cost on completion of 50% of training period of the batch commenced training. Further 30% of the training cost on completion of 100% training period of the batch and on receipt of placement details. Balance 20% of the training cost will be paid on production of 70% placement confirmation from the Employer about the placement and joining of the trainees issue of SCVT certificate.
- 15. Already trained candidates should not find a place in the training proposed. A Certification / Declaration in this regard should be submitted by Training Provider.
- 16. Training should be provided to unemployed youth and regular students of any Educational Institution should be inducted for skill training courses.
- 17. Training also to be conducted in soft & entrepreneurship skill (100 hrs) for all the modules having more than 300 hrs duration. All trainees should be taught on soft skills and values.
- 18. There should be display of board with TNSDC logo and name should prominently be displayed as back drop for the stage.
- 19. Proper documentation of the training of each batch by way of Videography, Photograph (both hard and soft copy) should be furnished to TNSDC while claiming payment.
- 20. The training provider should submit the details of trainees minimum 10 days before commencement of the training programme to the TNSDC for all the batches.
- 21. The Training providers should produce relevant records / document during the inspection carried out by the Department officials.
- 22. Before submitting the final claim training provider should submit the complete details of the trainee placement like name of the trainee, firm in which he is placed with address, job position, monthly salary, along with skill training certificate number.
- 23. Training Providers should submit Utilization Certificate for all payments received in the prescribed format.
- 24. Wide Publicity should be given for selecting candidates through Media, Collectorate & local cable TV and Advertisements through Banner, Poster, Pamphlets, etc.

- 25. While selecting the candidates for skill training the training provider should give preference to women, destitute widow, rural candidates, SC/ST and differently abled candidates and transgenders as applicable for the skill training.
- 26. Training provider should not collect any training fee or other charges from the candidates. Violation of the clauses will lead to cancellation of approval from TNSDC.
- 27. The Empanelment of Training Provider is ordinarily valid for a period one year from the date of issue of order. Based on the performance of the Training Provider it will be extended further up to maximum of 3 years. It is further informed to quote the Training Provider registration number in all future correspondences.
- 28. Batch wise / Course wise scheduling of training proposal should be put up in the notice board as well as in Training Provider Web portal.
- 29. Study kit (Study materials, Notebook, Pen, Pencil etc) should be supplied to the Trainees by Training Provider at their own cost.
- 30. Each candidate should be provided T-Shirt / over coat with printing of TNSDC logo (Rear side) as well as training institute logo front side which is to be supplied by Training Provider.
